The Board is pleased to announce that Shenzhen Xiaozhao Network Technology Co., Ltd (深圳市小钊 网络科技有限责任公司), the Company's indirect wholly-owned subsidiary, has reported NPAT of approximately RMB 1.91 million for the 12-month period commencing from 22 October 2024 to 21 October 2025 (being the Earn-Out Period), and hence, the NPAT Target of RMB 0.75 million for the Earn-Out Period has been achieved with a surplus of approximately RMB 1.16 million or 154.7%. In accordance with the terms and conditions of the SPA, an external auditor duly appointed by the Company has conducted a special audit to verify the NPAT performance for the Earn-Out Period.

The 135,600,000 Earn-Out Consideration Shares currently held in escrow will accordingly be released to the Vendor's Nominees, Mr. Yuan and Mr. Wu, pursuant to the SPA.
